AGILITY FUEL SYSTEMS NAMES BARRY L. ENGLE AS CEO

Most recently he was CEO of Think Holdings AS, a manufacturer of electric vehicles in Oslo, Norway. Prior to joining Think, Mr. Engle was from 2008 to 2010 the President & CEO of New Holland Agricultural Equipment, S.p.A, a world leader in agricultural equipment based in Turin, Italy.

Engle is a veteran of Ford Motor Company, where he spent most of his career, rising through a variety of positions between 1992 and 2008 in North America, Latin America and Asia. These include President & CEO of Ford of Canada, President of Ford Brazil & Mercosul, General Manager of Ford Division Marketing, General Manager of Worldwide Direct Market Operations, Director of North American Product Planning & Strategy and General Marketing Manager, Parts & Service Division.

Engle also has first hand automotive retail experience, having been a Chrysler Plymouth Jeep dealer in Salt Lake City, Utah. He earned a Bachelor of Arts in economics from Brigham Young University and an MBA from the Wharton School of the University of Pennsylvania.

"Barry has worked internationally and with large corporations, with significant managerial and operational experience in an OEM setting. But he also has an entrepreneurial spirit and experience with smaller companies that will serve him well. This combination makes him uniquely qualified to lead Agility to the next level," said Michael Gallagher, Agility's Chairman.

Agility Fuel Systems was formed in December, 2010 through the merger of FAB Industries (FAB) and Enviromech Industries (Enviromech), both leaders in the engineering and manufacturing of natural gas fuel systems. Element Partners, a clean technology-focused private equity fund, provided equity capital to complete the transaction and assumed a significant equity position in the new company along with board participation. Sam Gabbita, a partner at Element and Agility board member, said, "We have made good progress in integrating the two companies. And, we're seeing ever greater interest from heavy duty vehicle fleets in natural gas as a transportation fuel. So as we now look to continue to scale the business, we are very pleased to be able to bring in Barry as CEO. His OEM experience, energy and leadership will make him a great addition to the Agility team."

Commenting on his new position, Mr. Engle said, "I'm excited to join Agility at this point in time. The economic and environmental benefits of natural gas are compelling for our heavy duty fleet customers. And we've earned a reputation for providing them the most reliable, best engineered fuel systems on the market along with great customer service. I look forward to working with the team as we continue to take care of our customers and build the business."
